In pursuance of PCPO, E. Rly's letter quoted under reference, the following notification is issued:-

In order to fill up 01 (One) post of CIT in Level-7 (grade Pay 4,600/-) and 08 (Eight) posts of TTI in Level- 6 (Grade Pay 4,200/-) in HQrs Ticket Checking Squad under PCCM/Eastern Railway/ Kolkata, volunteers from same grade of CIT & TTI are invited. Selection will be made through Viva-voce, screening of Service Record and last 03 years APARs.

Candidates must fulfil the following conditions:-

1. Posting in HQrs Squad shall be for 03 years which may be extended if required.
2. Applicants must have experience of 02 years of working in the grade for which they opt.
3. Applicant's average monthly earning from detection of penalty and luggage cases should be more than 40,000/- during last 06 years.



No option will be accepted after the date specified above. However administration reserves the right to extend the last date of receipt of option.

The staff so selected will work in HQrs Squad on a tenure basis for a period of 03 years. Administration will have the discretion to repatriate candidates earlier without assigning any reasons.

Option once exercised is final and no refusal will be entertained in future under normal circumstances.
