Sub: Formation of a panel for the post of Staff & WI in PB-2:Rs.9300-34800/- + Rs.4200/- (GP)/Level-6 (7th CPC) from all Deptts. of ASN Divn against 35% Quota.

It has been decided to hold a selection (written test) for formation of the panel for the post of Staff & Welfare Inspector in PB-2 Rs.9300-34800/- + Rs.4200/- (GP) / Level-6 (7th CPC) from all department of ASN division by the competent authority. The size of panel will be 02 (UR - 02, SC - 00, ST - 00).

Accordingly options are invited from staff of all departments of ASN division as per following eligibility criteria.

ELIGIBILITY CRITERIA [SI.Circular No. 138(10)/2002& RBE NO.11/2020]

The following staff are eligible for the post of staff & Welfare Inspector in level -6 of Pay Matrix (Corresponding GP Rs.4200/- in PB-2):-

i) Group 'C' staff(level-2 and above) in possession of any of the following qualifications irrespective of the grade or length of service or other educational qualifications.

a) Diploma in Labour Welfare/Social Welfare; b) Diploma in Labour Laws;

c) LLB with Paper(s) in Labour Laws;

d) Post Graduate Diploma in Personnel Management awarded by an Institution recognized by the Government of India; and

e) MBA with paper(s) in Personnel Management/HR awarded by an Institution recognized by the Government of India.

ii) Staff who are working in level-6(GP.Rs.4200/- in PB-2) or above on regular basis will not be eligible to appear in the aforesaid selection.

iii) Erstwhile Group 'D' staff who have completed at least 7(seven) yrs. Service in erstwhile Gr'D" as on 01.7.20 or before and are in possession of any of the qualifications mentioned (i) above.

iv)Staff in the grades level-5(GP.Rs.2800/- in PB-1) & level-4 (GP.Rs.2400/- in PB-1), with 5(five) yrs. Service as on 01.7.20 or before in the respective grade in case the higher grade does not fall in normal line of advancement otherwise, 5(five) yrs. service together in these grades.

v)Staff in the grades level-5(GP.Rs.2800/- in PB-1) & level-4 (GP.Rs.2400/- in PB-1) who are graduates irrespective of the length of service in these grades provided the staff concerned have successfully completed the probation in the respective grade.

vi)Staff in the grades level-3(GP.Rs.2000/- in PB-1) & level-2 (GP.Rs.1900/- in PB-1) who are graduates and who have completed not less than 7(seven) yrs. Service as on 01.7.20 or before in the respective grade in case of higher grade does not fall in the normal line of Advancement, otherwise 7(seven) yrs. Service together in these grades.

All the Supvrs./Unit-in-charges of this Division are requested to give wide publicity amongst the staff working under their control and application from the eligible staff may please be called for and send the same along with statement in the enclosed Proforma positively by 06.07.2020 to E/Gaz Sec under Sr. DPO/ASN. No application in any case, sent after target date, will be entertained. Before forwarding the applications, the eligibility of the individual applications may please be checked carefully according to the given criteria and correct eligibility be ensured.

It may be noted that option once submitted treated as final and the employee on being selected as S&WI in Level-6 (GP.Rs.4200/- in PB-2) should sever all connection with his parent cadre.

It is also requested that while forwarding applications of the volunteers on deputation, it may be ensured that the volunteers are holding lien in this division as indicated in the CPO/ER/KKK's Sl. No. 2/92.
