Reference above, it is intimated that the date of Written Test in connection with the above selection which was scheduled to be held on 25.04.2020 has been re-fixed on **3rd October' 2020(Saturday) at 11.30 hours in PCPO's Office** , Eastern Railway , Fairlie Place,Kolkata.


The eligible candidates whose names were published vide this office letter of even No. dt. 02.03.2020 may be advised to appear at the Examination in time with the stipulation that in future if it is found that any of the candidates does not fulfill the eligibility conditions as per circular dated 10.05.2019 but inadvertently called for written examination his candidature will be cancelled at any later stage. The candidates may also be advised that there will be no continuation Written Test and in the event they fail to appear at the Written Examination on the aforesaid date even on Medical Ground they will have no further scope for the said Examination. Carrying of electronic items like Mobile phone, digital diary etc. is strictly forbidden. If any candidate is found in possession of Mobile phone or any such device in the examination hall, his candidature will be cancelled straight way.

The eligible candidates may further be advised to report at PCPO's Office, Eastern Railway, Fairlie Place, Kolkata one hour before the Examination start i.e. at **10.30 hrs. on 03.10.2020(Saturday)** with letter of their identification from their respective Offices duly attested by a Gazetted Officer and they may be warned that if they fail to bring the letter of their identification they may not be allowed to sit for the Examination.

The candidates may again be advised that in the event, if it is found, at any later stage, that any of the candidates did not fulfill the conditions of eligibility as circulated earlier, his/her candidature will liable to be cancelled.

N.B : All candidates will have to undergo Thermal screening before entering in the examination centre and should have admissible body temperature . Wearing of Musk is compulsory in examination Hall.
