

GOOD WORK DONE BY RPF/E.RLY. IN THE MONTH OF OCTOBER 2020

RESCUE OF CHILDREN :

During this month, 11 minor girls, 10 boys and 01 new born baby were rescued from different Railway stations and Railway premises of Eastern Railway. All of them were handed over to their respective parents/NGOs on proper documentation.



ASSISTANCE RENDERED TO INJURED PERSONS:

During this month, total 05 injured male persons & 02 female injured persons were rendered assistance in hospitalizing for their treatment.

RECOVERY OF LUGGAGE :

During this month, 22 No. of luggage/bags containing personal belongings etc. (total valued Rs.6,27,826/-) were recovered from different stations/trains. Later on, the recovered articles were handed over to the respective owners on proper documentation.



ARREST UNDER RP(UP) ACT :

During this month, total 25 persons were arrested under Railway Property (Unlawful Possession) Act with recovery of Railway property valued Rs.1,64,405/- in 11 cases.

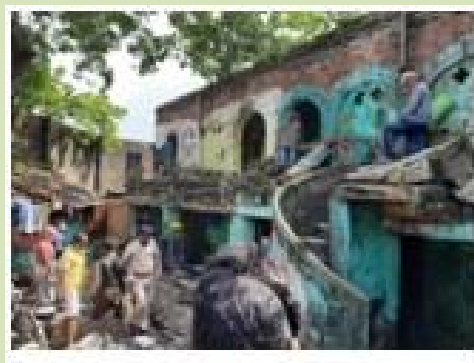
ARREST UNDER RAILWAYS ACT :

During this month, total 751 offenders were arrested under different sections of Railways Act including 15 touts U/S 143 of Railways Act and all of them have been prosecuted.



REMOVAL OF ENCROACHMENT :

During this month, total 320 No. of unauthorized structures were removed from Railway premises over the jurisdiction of Eastern Railway.



RECOVERY OF LIQUOR :

During this month, RPF/Eastern Railway recovered total 426 bottles country liquor & 267 bottles foreign liquor total valued Rs.9,87,850/- with arrest of 01 person.



RECOVERY OF CONTRABAND GOODS/ARTICLES :

During this month, RPF/Eastern Railway recovered the following contraband goods/articles and handed over to the concerned Custom Authority for further legal action.

ARREST UNDER IPC :

During this month, RPF/Eastern Railway arrested 05 persons involved in the theft of passenger belongings and other IPC crime with recovery of stolen articles valued Rs.10,06,000/- (approx.). The arrested persons were handed over to the concerned GRP/Local Police authority for taking legal action under appropriate sections of IPC.



RECOVERY OF CASH:

During this month, RPF/Eastern Railway recovered cash Rs.74,52,000/- and handed over to concerned authority for taking legal action.



FAKE APPOINTMENT :

During this month, RPF/Eastern Railway apprehended 03 persons with recovery of fake appointment documents. The apprehended persons were handed over to concerned Local Police authority for taking legal action under appropriate sections of law.

WILD LIFE:

During this month, RPF/Eastern Railway recovered 74 live tortoises valued Rs.29,600/- and handed over to Range Officer of Forest department, Malda (West Bengal) for taking legal action

ADDITIONAL WORK WITH REGARD TO COVID-19 :

- ❖ After announcement of lock down, RPF officers and staff have been ensuring security of all Railway assents including stations, stabled rakes, running goods/parcel trains more vigilantly and workshop etc. by deploying adequate number of staff round the clock at important stations/Railway installations/trains.
- ❖ Thermal scanners are being used by RPF officials to scan passengers coming by special trains and to scan staff coming to office to find out suspected infected persons.
- ❖ RPF has extended full assistance to State Administration in locating suspected infected persons and detaining persons trying to move to distant places using Railway track. RPF has extended full co-operation/assistance in testing, tracking, isolation and quarantine of suspected infected persons.
