

Keeping in view the extenuating circumstances which has posed numerous difficulties for both Staff and Officers to vacate their accommodation timely due to non-availability of resources or any other reason which is beyond their control, it is decided that the existing powers vested with the General Managers to grant extension for a period of One year, an additional period of three months be delegated to permit/regularize accommodation for over and above the existing period, if such cases are justified in the respective cities/towns.


