CORRIGENDUM

The subject 30% LDCE was initially notified in terms of this office letter of even no. dated 30.03.2022 and, subsequently, a list of 33 (thirty-three) eligible candidates for appearing in the written examination for the same, scheduled to be held on 16.07.2022 & 17.07.2022, was circulated vide letter of even no. dated 06.06.2022 and **necessary pre-selection training imparted.**


2. Now, consequent on the issue of Railway Board's letter under reference (ii) above introducing modified selection procedure for 30% LDCEs of current vacancy cycle in respect of all Departments having Organized Services (circulated vide PCPO/ER's **Sl.No 81/2022** which the candidates are requested to go through carefully for instructions), the subject LDCE notifications of Accounts Department vide reference (i) above stands modified accordingly. The following modifications may be particularly noted :

(I) As per new selection procedure, LDCE (30%) examination will be conducted by DG/NAIR through Centralised Computer Based Objective Type examination. LDCE will be one stage only and will comprise of only 1 paper with the following set up:

(a) Single paper of 150 marks comprising 100% objective type Multiple Choice Questions with following distribution of marks:

01	Technical (Professional) subject	80
02	General Knowledge including optional Question of 15 marks on Official language Policy & Rules)	40
03	Establishment & Financial Rules	30

- (b) Qualifying Marks : 90 Marks
(c) Duration : 03 Hours
(d) Question paper will have 175 questions out of which 150 questions are to be attempted.
(e) 01 mark will be allotted for every correct answer. There shall be negative marking for incorrect answers and 1/3rd of marks allotted for each question will be deducted for every wrong answer.
- (II) Syllabus for the LDCE examination will be as prescribed vide earlier notification of even no. dated 30.03.2022. However, as it is based on old pattern when there were two papers – Paper-I and Paper-II in the LDCEs, the Centralized CBT shall be held from the said syllabus after amalgamating the topics prescribed in Paper-I and Paper-II of respective syllabi.
- (III) Optional Questions on Official Language policy and Official Language Rules in the LDCEs shall be included in terms of provision contained in Para 204.3 of IREM Vol.I.
- (IV) Examination for 30% LDCEs will be held on a single day only across Indian Railways.
- (V) Railway-wise list of candidates along with marks scored by them in the written examination will be prepared by DG/NAIR who is assigned the task of conducting the exams and will be furnished to respective Zones/PUs.
- (VI) Medical & Viva-voce of successful candidates will be conducted by Eastern Railway and thereafter final panel will be issued according to the vacancies, on the basis of merit, tentatively within one month from the date of receipt of result from NAIR.
- (VII) CBT for 30% LDCEs for a particular department for Zones/PUs will be held **on the same day** across Indian Railways. **Thereafter no request for a supplementary exam will be entertained in any condition.**
- (VIII) The tentative schedule for finalizing the various stages in LDCEs of current vacancy cycle through CBT is given as under :

3. In this connection it is requested to give wide publicity to this notice and also of the afore-mentioned instructions of Railway Board to *all the eligible candidates* as per Para-3 of this office earlier notification of even no. dated 30.03.2022, so that those candidates *who did not give willingness against notification dated 30.03.2022 but are willing to appear in the examination as per the revised exam procedure* may submit their willingness in the prescribed proforma in Annexure-A to their respective Controlling Officer on or before **25.07.2022.**

Candidates who are already eligible in the subject LDCE examination in terms of list published vide Annexure-II this office earlier notification of even no. dated 06.06.2022 *need not submit fresh willingness*. The candidates, whose names have been circulated as eligible candidates *ibid*, may also go through the revised norms as above. No reference in this regard will be entertained later.

A confirmation to the effect that this notification has been got noted by all eligible staff under their respective control should be sent under the personal signature of the respective Controlling Officers within 15.07.2022.

4.1 The Controlling Officer must send a consolidated statement of the willing candidates, who are found eligible as per Para-3 of this office notification dated 30.03.2022, enclosing the following :-

(a) Consent of the candidates in the prescribed proforma (**Annexure-A**).

(b) Bio-data of the willing and eligible candidates in the prescribed format (**Annexure-B**).

4.2 The Controlling Officers should send the consolidated statement along with enclosures to Dy.CAO(G), E. Railway, Kolkata under D.O. cover not later than 29.07.2022. He or she will be personally responsible to ensure that the proforma and statements are filled up correctly, and complete in all respects, duly signed by the candidates, wherever so required. No application under any circumstances will be accepted after this cut-off date.


4.3 In case of candidates who are on deputation, leave, training or working in ex-cadre organization, if any, the receipt of acknowledgement of the notice and the consent of the candidates as per **Annexure-A** should be obtained by the office/unit from where the candidate concerned proceeded on such deputation, leave etc and sent along with **Annexure-B** *ibid*.

5. **Above scheme of LDCE is provisional and any change in the scheme will be notified according to subsequent guideline issued by Railway Board in this regard.**
