**Sub: Formation of a combined panel of AFAs(Group-B) of Eastern Railway
& Metro Railway/Kolkata in 7th CPC Level-9(6th CPC PB-2,GP-5400)
against 70% quota for the year 2023-24 through Centralized Computer
Based Objective Type examination (CBT).**

This is in continuation to this office earlier letter of even number dated 30.11.2022.

2. As already stated, it has been decided to conduct the 70% selection for formation of a combined panel of Assistant Financial Advisers (Group-B) of Eastern Railway and Metro Railway/Kolkata in 7th CPC Level-9 (6th CPC PB-2 GP-5400/-) for the assessment period **01.01.2023 to 31.12.2024** through centralized CBT, as scheduled vide Board's letter no. E(GP)2022/2/4 dated 18.10.2022, on **22.01.2023** and **29.01.2023** (supplementary), to be followed by 30% LDCE. Accordingly, pending circulation of the no. of vacancies with community-wise break-up, willingness/unwillingness from all the candidates borne on the circulated integrated seniority list was called for.

3. In terms of Railway Board's letter No. E(GP)2005/2/50 dated 03.08.2005 & 21.02.2007, after formation of fresh panels for selection/LDCE the empanelled candidates may similarly be posted on either Railway (Easter or Metro) depending upon the availability of vacancies. However, all such employees who may be posted against Group-B post of Metro Railway on the basis of Eastern Railway's panel, will hold a lien on Eastern Railway only and will not become Group-B Officers of Metro Railway.

4. The size of the panel for 70% selection will be **14 (Fourteen)** with following community-wise break-up :-

UR – 09, SC – 02 and ST – 03 = 14

5. In terms of RBE No.97/2022 read with RBE No. 74/2022, circulated vide PCPO/ER's SI.No. 112/2022, reservation would be provided in promotion from Group 'C' to Group 'B' to persons with Benchmark Disabilities (PwBDs) as per office memorandum of MoPPG&P, DoPT No.36012/1/2020-Estt.(Res.-II) dated 17.05.2022. In view of the above, **01(One)** vacancy shall be reserved for PwBDs in the Block period 01.01.2023 to 31.12.2024 for the AFA selection. The functional classification for reservation to 1st roster point for PwBDs would be B (Blind) & LV (Low Vision) for the post of AFA for promotions from Group 'C' to Group 'B' posts.



6. A list of candidates who were originally eligible in order of integrated seniority, as published vide this office notification dtd. 30.11.2022 *ibid*, to appear in the above test is enclosed as **Annexure-A**. Other candidates borne on the said list have been considered as stand-by in terms of extant instructions.

7. Based on the willingness/unwillingness received from all the candidates borne on the published integrated seniority list *ibid*, the list of willing candidates, in order of seniority, found eligible to appear for the 70% Selection (CBT), is enclosed as **Annexure-B**. *Any discrepancy found or reported in the list may be intimated to this office, through proper channel, for necessary rectification, if any, by 30.12.2022. Eligible candidates under your control (i.e. as per Annexure-I of notification dated 30.11.2022 *ibid*) who have given unwillingness in terms of the said notification dated 30.11.2022 are given another chance to give their willingness, if so desired, by 30.12.2022. Annexure-B *ibid* would be provisional to that extent.* No fresh candidature would be entertained beyond 30.12.2022 and the list treated as final.

8. It is informed that online pre-selection coaching classes for the ensuing 70% selection (CBT) will be held on and from 04.01.2023 to 17.01.2023 as per the enclosed programme schedule at **Annexure-C**. Necessary Meeting i.d. and Password will be informed subsequently.

8.1 In terms of Railway Board's letter No. E(GP)2010/2/39 dated 28.08.2019, Pre-selection coaching classes are mandatory for the SC/ST candidates only. This facility of pre-selection coaching classes is, however, being extended to the willing candidates of the general community in administrative interest along with the reserved community candidates. If any staff does not attend the class on account of leave, sickness or any other reasons this cannot be treated as an excuse for demanding another coaching class. They will have to wait for the next coaching class or make their own arrangements for self-coaching.

9. In terms of Rly. Board's letter No. E(GP)2022/2/4 dated 07.12.2022 (copy enclosed) the pattern of examination for 70% Selection for promotion to Group 'B' post of AFA in Accounts department has been further modified and , accordingly, it would be as follows :-

a)	One paper on Professional Subject including optional questions of 10 marks on Official Language Policy & Rules.	100 marks
b)	Qualifying Marks	60 with reservation as per extant rules.
c)	Duration	2 hrs.

9.1 Furthermore, the syllabus would be as modified vide Board's letter of even number dated 07.12.2022 *ibid* for the 70% selection (as also 30% LDCE) in respect of Group 'B' post of AFA in Accounts Department.

9.2 The viva-voce test will be for 50 marks (25 marks for viva-voce and 25 marks for record of service). The qualifying marks for viva-voce test will be 30 including at least 15 marks in the record of service.

9.3 Unless the qualifying marks are obtained in the written test candidates will not be called for viva-voce test.

10. In terms of Para 206.2 of IREM Vol.I, Group-C employees qualifying in the selection for promotion to Group-B post would be required to pass the prescribed medical standard. Only those who qualify in the medical examination of prescribed standard shall be called for viva-voce.

11. This should be given wide publicity amongst *all* the eligible candidates. The controlling officer of the respective offices should get the acknowledgement from the candidates to the effect that they have noted the contents of this circular. *Respective Controlling officers are hereby nominated for being the authority responsible to ensure that this circular is brought to the notice of all the candidates/eligible employees working under their respective units or belonging to them.*

12. In this context, it is reiterated that APARs of the candidates should be kept in readiness so that there is no inadvertent error/delay in complying with the timeline prescribed by Board. Information/confirmation regarding availability of APARs for the years 2017-18, 2018-19, 2019-20, 2020-21 & 2021-22 in respect of the willing and eligible candidates under your control should be sent by 06.01.2023 , positively.

13. Overall, the selection procedure prescribed in the Master Circular No. 68 & IREM (1989 Edition) read with provisions/amendments will apply.

14. Further instructions on the issue will be notified based on subsequent guidelines issued by Railway Board/NAIR/PCPO, if any, in this regard.
