NOTIFICATION

Sub: Re-engagement of Retired Railway Officers in exigencies of service-setting of Gati Shakti Unit (GSU) of Howrah Division.

In terms of Railway Board's letter No. 2021/W-1/Genl/Gati Shakti / Pt. dated. 20.02.2023, it has been decided to re-engage 02(two) Retired Railway Officers(JS/SS/JAG) who have retired from Railway Service from Eastern Railway, on monthly remuneration basis part Gati Shakti Unit (GSU), Howrah Division of Eastern Railway.

Therefore, applications of Retired Railway officers (JS/SS/JAG) who fulfills the following terms & conditions and have worked in Howrah Division Jurisdiction & retired from Eastern Railway are invited as to reach E-1 /GAZ Section/Personnel Branch of Sr. DPO/HWH's office on or before **30/06/2023**.

The details of posts two (02) of **Gati Shakti Unit/Engg. (GSU/Engg.)** of Howrah Division , Eastern Railway which are to be filled up are as follows-

Sl. No.	Department	Post to be filled up	Age limit	Preference of criteria
01	Gati Shakti	02(Two)	Below of the age of 65 yrs.	i) Selection shall be done on the basis of number of years worked in Civil Engg. Project works in Railway. ii) Retired officers who have worked in Howrah Division shall be given preference.


Officers (JS/SS/JAG) retired from Eastern Railway desirous for re- engagement, may submit their offline applications if any in the prescribed format at Annexure 'A' (Copy enclosed) to OS/E-1/GAZ Section/Personnel Branch, Eastern Railway/Howrah or online application over to E-Mail ID **srdpo.erhwh@gmail.com** on or before **30.06.2023** positively, thereafter no application will be entertained in any circumstances.

1. GM/E.Rly. is empowered to re-engage retired Railway officers in exigencies of service for setting of GSU/Engg. for Howrah Division within the overall provision in estimate of the projects being executed by the GSU /HWH.
2. ***All the Railway Retired Officers (JS/SS/JAG) who have not attained the age of 63.5 years above on the closing date of Notification for re-engagement purpose will be eligible .***
3. **The eligibility criteria for selection of Retired Officers will be as follows-**
 - i. While re-engaging such officers, medical fitness of the appropriate category shall be obtained from the designated authorities as per existing practices.
 - ii. The period of engagement shall be initially for one year and further extendable as per requirement.
 - iii. Maximum age limit of the re-engagement shall be 65 years.
 - iv. The engagement of consultant shall not be considered as a case of re-employment.
 - v. 12 days leave in a calendar year on pro-rata basis is admissible.
4. Suitability / Competency of the retired officer shall be adjudged before such re-engagement by a committee of three PHODs/CHODs/SAG as appointed by **GM**.

5. Monthly remuneration of a retired Railway Officers being re-engaged will be governed in terms of Railway Board's letter No. 2018/Trans Cell/S&T/Contractual Staff dated 25.10.2018. Monthly remuneration of retired officers being re-engaged be determined by reducing Pension-from his/her last pay drawn i.e **(Last Basic pay + DA) – Pension)**
6. Re-engaged officers should be discharged immediately on joining of selected candidates from UPSC or departmental selection or as per the recommendation of PHOD/CHOD concerned.
7. Duty Pass may be provided for stretch of journey involved on duty.
8. The Re-engaged officers will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc) . For absence if any, appropriate deduction from salary/wages will be made from the monthly remuneration.
9. The Re-engaged officers shall not entitled for perquisite such HRA, CCA, Transport Allowance. Residential accommodation etc. However ,when required to travel in connection with official work TA/DA admissible to regular employee working in the same Grade will be admissible.
10. Copy of any of the following documents should be attached with the application and it is mandatory.
 - a. Service Certificate
 - b. Pensioner Identity Card
 - c. Pension Payment Order
11. This scheme is valid till further orders.


