A. Eligibility:-


- i. Staff of Accounts deptt. & Personnel deptt. Working in Level-6 or Level-7 in Pay Matrix, on regular basis.
- ii. Any staff who has been transferred from Vigilance Unit, irrespective of the period for which he has served there, will be eligible after undergoing a cooling period of at least two years, for further posting in Vigilance unit.
- iii. The staff should have profound integrity and should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed with Major/Minor penalty in any passed Vigilance case.
- iv. The staff who have completed at least five years' service in the Railways as on 21-09-2023.
- v. Candidates should have working knowledge of Computer.

B. Other conditions :-

- i. The post of Chief Vigilance Inspector (A/cs.&Personnel) is an ex cadre post and its normal tenure is 03 years. However, an Inspector can be repatriated on or before completion of the tenure without assigning any reason whatsoever.
- ii. Applications in the prescribed proforma must reach this office on or before 16-10-2023.
- iii. The notification may be given wide publicity amongst the staff.
- iv. PFA & PCPO may please circulate this notification to all eligible staff working in other units/organizations having lien in Eastern Railway.
- v. Eligible candidates may forward their applications through proper channel in the enclosed proforma only. It should be ensured that candidates, if selected, shall immediately be spared.

In case of Metro Railways, applications of eligible volunteers, having proven integrity may be forwarded through Zonal Vigilance alongwith the current vigilance /SPE /DAR clearance and the past vigilance history of each applicant within due date.
