Railway Board, considering possible all aspects including Parliament Election & etc. instructed to make necessary preparations for conduct of the Elections between July-August 2024.


You are, therefore, requested to keep readiness by updated voter list, House Rent, Water charges, Electricity Charges etc. for holding of Secret Ballot Election.

Sub: Notification for Secret Ballot Elections for recognition of Trade Unions on Zonal Railways, Metro Railway/ Kolkata, CLW/ Chittaranjan & RCF/ Kapurthala.

Ref: Hon'ble High Court of Delhi's order dated 03.08.2023 and 14.12.2023.

Whereas, in terms of Board's order No.ERB-I/2023/23/60 dated 17.11.2023, a Secret Ballot Election Committee has been constituted for verification/ recognition of Trade Unions on Zonal Railways, Metro Railway/ Kolkata, CLW/ Chittaranjan & RCF/ Kapurthala. The Committee is already in the process of seeking comments of all stakeholders on the draft Modalities for holding the next Secret Ballot Elections for verification/ recognition of Unions on Railways. Complete support is to be provided to the Committee's process so that on completion of review/ updation of the Modalities and other related requirements by the Committee, the Elections of the verification/ recognition of Unions may be conducted.

2 It may, however, be noted that annually there is a steep increase in loading in Railways in the months of February and March and summer specials are operated in very large numbers in the April, May and June. Coal loading for power generation is also at its peak during April to June. The essential safety preparations are needed to be undertaken before the onset of Monsoons. General Elections to the Parliament will also be held in the above period. The above activities are to be undertaken with maximum attention.

3 Considering above, the time required by the Committee and operational requirement of Railways, the Elections of the Unions are to be held in July-August, 2024.

4 Railways may, accordingly, make necessary preparations for conduct of the Elections between July-August, 2024. This issues with the approval of the competent authority.
