

**WALK – IN INTERVIEW FOR ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS**

Eastern Railway Sealdah Division desires to form a panel of doctors to be engaged as ‘Contract Medical Practitioners (GDMO)’ on full time contract basis for a duration of one year on the following terms and conditions:-

While attending the Interview, the candidates are requested to bring all relevant certificates in original with attested copies of the same in support of age, qualification, medical registration, experience etc. and two passport size photographs self attested and application duly filled in as per format given (with one of the two photographs pasted).The candidates should be prepared to stay back for one day, if required, at their own expense.

**:TERMS AND CONDITIONS:**

**1. NAME OF THE POST:** Contract Medical Practitioner (CMP) on full time contract basis.

**2. NATURE OF ENGAGEMENT:**

(a) The engagement is purely on contractual basis for one year or till regularly UPSC selected Doctors (ADMO/DMO/Sr.DMO) become available whichever is earlier. Further the services of these doctors are also terminable before the expiry of one year. The services rendered as contract doctors is a stop gap arrangement and will not have any bearing in respect of consideration of the period in case of regular selection through UPSC. It will also not confer any right for automatic regularization/absorption in any circumstances. The entry level age limit of candidates for appointment as Contract Medical Practitioners (CMP) is 53 as on 01.01.2020. CMP will not continue as such after 65 years of age or up to 12 terms of engagement whichever is earlier. The terms of engagement shall not exceed more than one year in each term.

(b) Retired IRMS Officer/ Retired Govt. Medical Officer of state Govt. and Central Govt. are also eligible to engage themselves as CMP. The number of annual term of engagement of Retired/Government doctors engage as CMPs is revised from the exiting FIVE to SEVEN subject to attaining the age limit of 67 years whichever is earlier and each term of engagement shall not more than one year.

**3. REMUNERATION:**

i) Rs.75,000/- per month for G.D.M.O. if Govt. accommodation is not provided. Contract Medical Practitioners for whom Railway accommodation is provided with an amount equivalent to the sum of HRA and license fee of the accommodation so provided will be deducted from the monthly remuneration.

ii) Retired railway doctors/State Govt./Central Govt. doctors will get fixed remuneration of Rs.75,000/-per month subject to the condition that Pay plus pension should not be more than the last pay drawn with the same terms and conditions as per Board's instructions dated 16.07.2012.

#### 4. OTHER FACILIT

One set of 1<sup>st</sup> class complimentary pass for self & family during each contract which shall be issued after three months of regular contract service(except retired railway doctors).

Contract Medical Practitioner can avail free medical treatment for self only. Other condition apply.

Expenses on out station journey connected with contracted work will be borne by the Railway. Daily allowance at specified rates will be admissible for such work.

#### 5. QUALIFICATION:

MBBS from a recognized University and must have completed rotating internship for one year and should be in possession of a valid Registration Certificate of any of the State Medical Council of India.

(b) Not exceeding 67 years for retired IRMS Officers/retired Govt. Medical Officers of State Govt. and Central Govt. subject to maximum seven terms of one year each upto the age of 67 years. (c) Reservation Policy will be followed as per extant rules.
