Sub: Re-engagement of Retired Railway Employees on Daily Remuneration basis under SDAH Division, Eastern Railway.


In continuation to this office notification number of even number dated 29.12.17 applications are invited from Retired Railway employees of Sealdah Division on the following Terms and conditions for re-engagement in the Administrative office of Divisional Railway Manager, Eastern Railway, Sealdah of this Division against the post of Stenographer.

TERMS & CONDITIONS FOR RE-ENGAGEMENT

1. Retired employees should not have been covered under Safety related Retirement scheme (SRRS/LARSGESS).
2. Removed/Dismissed/Compulsory /Voluntarily Retired employees are not eligible for re-engagement.
3. Medical fitness in appropriate category is mandatory.
4. Maximum age limit for such engagement shall be 65 years as per latest guideline of Rly. Bd's RBE No.193/2017 & the scheme is valid up to 01.12.2019.
5. Monthly remuneration of a Retired employee being re-engaged will be determined by reducing Pension from his/her last pay drawn(i.e. Basic Pay + DA) .
6. Suitability/Competency of the retired employee should be adjudged before such engagement as per requirement of the concerned Department of the Division.
7. Services of such re-engaged employees may be terminated at any point of time for un-satisfactory service without any prescribed procedure.
8. Re-engaged employee will be discharged immediately on joining of selected candidates from RRB against each post.
9. The re-engaged Retired employee is liable to be posted at any place of Sealdah Division as per Departmental requirement.

The retired employee desirous of taking this opportunity may prefer appeal to the concerned Branch Officers from where they have retired in the prescribed Format along with the attested copies of PPO, Service certificate, Last Pay Slip and Retired Railway Employee Identity card issued to them.
